The Group AGM was held in February and all the officials were re-elected for a further term of office. The general consensus of opinion appeared to be that the Group was being run in the right manner, so no changes were made to our run and meeting policies. The question of finance was discussed at length, with several members pointing out that the cost of running the Group was falling on the shoulders of those members who bother to attend meetings and official runs. I have therefore applied for a promoter's licence under the Lotteries Act, which will enable us to raise J funds from outside sources. The licence will cover the TRF as a whole, so if any Groups are planning external fund raising activities, save yourselves £10. on the licence fee.

Unfortunately, the weather forced the cancellation of the official February and March runs. Some of our lanes are just becoming usable again after being blocked by snow continuously since Docember. However, the weather did not prevent an intrepid lane clearing party from doing their thing on Jack Lane at Bradfield - good effort lads.

Our first March meeting was brightened up by a visit from Pete Plummer and Geoff Diamond, who laid on a most entertaining slide show. Several of us failed to understand the photographic techniques involved, but the finer points of Pete's last four slides attracted close attention.

Local Row work has continued, despite the snow. In South Yorkshire, Derek McGinlay accompanied me to a public meeting to defend our trails over Wharncliffe Chase, which is currently the subject of a local planning review.

Surprisingly, no opposition was encountered and we even managed to agree with the Ramblers Association spokesman on several points. Exploration in the Barnsley area will be needed in the near future to propare for the limited review due later in the year.

Several hysterical reports have appeared recently in the Derbyshire Press, despite our efforts to engender a good relationship with the landowners and other users of the countryside. We could do without bad publicity at present, so if you are planning to ride in the area, please make sure to keep down the size of run parties and - above all - keep those bikes quiet! If you are not sure where to ride, please contact me and I will try and arrange a guide.

Rights of Way news: We now have a complete set of 1:50000 maps covering our area on which are marked up all currently usable 'Green Roads', i.e. Unclassified County Roads, RUPP's claimed as Byways and Bridleways where we have evidence of vehicular rights. The areas covered are: Derbyshire (south of Bakewell), Nottinghamshire, Leicestershire, Kesteven part of Lincolnshire and Staffs (Peak District). These maps will be available for copying at all Hast Midlands Group meetings, free of charge to members, but anyone wishing to have their maps marked up by my long-suffering wife, Kathleen, will be charged £1.

Per map, 50p. of which will go to Group funds.

Consultation is still taking place with the Leicestershire CC over their forthcoming Special Review. We had a meeting with the Footpaths Officer, a senior Highways Official and one of the County Solicitors, where we explained our position regarding Byway claims and especially the upgrading of several Bridleways. They appeared to be sympathetic to our proposals and we feel we will get a fair hearing from them over our detailed claims. The old county of Rutland, which was absorbed by Leics in 1974, is a problem area though. A large number of lanes were classified as Bridleways when the Council did their initial survey under the 1949 Act, which were in fact Public Carriage Roads. Conclusive evidence to support upgrade claims is very scant, as all the historical Official County Highway Maps have been lost or destroyed, including the 1929 Local Govt. Act delegation maps. A search through the minute books of the County Highways and Bridges Committee 1888 to 1939 has produced some success and further research through the 1910 Finance. Act field books and maps held by the Inland Revenue is continuing, as is investigation of Enclosure and Tythe Awards.

If anyone therefore has any evidence that may assist in these claims or has used any of the green roads in Rutland for more than three years, please contact me.

BRIAN THOMPSON'S ROW BIT

Rights of Way workers training weekend. Scotember 22/23 at Hollowford Centre, Castleton, Derbyshire. Arrive on Friday evening, depart Sunday at about 3 p.m. Bed, breaktast and evening meal 27.50. each for the weekend Mornings will be spont on the Peak green lanes, afterneons under instruction indoors at the centre from me and Dick Marshall (TRF Assistant Row Officer). Plenty of time for questions. No boring bectures. Charade type practice dealing with militant ramblers and Public Enquiry cross-examination techniques.

A green lane society has been set up and is now known as the Byways and Bridleways Trust, 9 Queen Anne Gate, Westminster, London. Formed to protect all green lanes with vehicular rights as Byways. ET elected on small executive committee. Horse riders and cyclists will form the main body and attempt to bring all amenity groups together, and it may get one expert to represent all bodies at Public Enquiries. It is run by Lrs. Braham, who is a Barrister, with Lady Kirk and Charles Shippan in key jobs. The TRF executive wish the Trust every success and will play an active part. The Trust has applied for charity status and a grant from the Countryside Commission. We are going to need all the friends we have in the difficult times shead.

Government changes in the law. In two phases: first to drop the requirement for the Secretary of State to confirm the Public Enquiry Inspector's decisions. The inspector will decide. This will be in the Countryside Bill 1979. Second phase: to drop all reviews and replace them with Orders on each lame as needed. Orders can be brought by County Council. Starting about 1981? All of which seems sensible; present delays are intolerable for all. BUT Clause 10, 2nd phase (Countryside Bill 1980) says that all RUPPs re-classified as Bridleways will have all vehicular rights extinguished. This is very bad news; we do not know if it also closes dual status BR/OCR lanes, or those awarded Public Carriage Road, or even if Section 34. (prescriptive rights) applies.

The ramblers, County Councils (especially Somerset), Countryside Commission and the Country Landowners Association are said to be in favour of this clause; they represent important pressure groups with a lot more clout than the TRF. We will do our best to get the Government to drop this clause, but we must accept the possibility of defeat which would be a major setback; large areas of the country would eventually be closed to trail riding and membership of the TRF would decline in these regions. Later I shall be asking all members to write to their MP's when the Bill comes before the House. Is this the beginning of the end?

legal aid: It is widely believed that the TRF will au omatically defend any member in court. The Committee ask me to point out that this is not so. Each incident has to be looked at on its merits.

Derbyshire: Two TRF members and two ACU members summonsed or 'riding a motor vehicle on open moorland' are to be defended in court by the same Bakewell solicitors who handled the successful Police vs. Green brothers TRF case in 1977. The riders assure me they were on the proper highway and this is seen to be another attempt to stop trail riding in the Peak Park. Riders were on the Jacobs Lacier track between Edals and Hayfield! which is an ! Unclassified County Road, although both a cess roads are closed by traffic order. If the charges are changed to contravening a traffic order we will still defend the action as a test case because they were not actually on the closed section. Police were waiting for them as they dropped down into the valley - a nice welcome!

Dear Nick,

Do all TRF members realise that downgrading Byways to Bridleway status can endanger not only our use, but all use. Bridleways can be ploughed and trees can be grubbed from the sides of them. This changes the whole character and individuality of byways for all time. Surely this reason could be explained to more reasonable people who do not realise the full effect of downgrading. There are too many people not understanding the full implications of these actions who, if fully informed, may support our point of view. It could even mean that old lanes with a wall either side of them could have the walls removed if the landowner owned both sides and the byway was downgraded.

Dear Brian,

A great victory! On Friday I called at the County Council Offices to enquire about the Transportation Sub-Committee meeting when the Traffic Restriction Order on parts of byways on the Binfield bridleway circuit was discussed. The Council had been asked by the Binfield District Council to close parts of the so-called Binfield bridleway circuit to vehicles as they felt that some yobs on motorcycles were using the circuit for pleasure and that this was wholly unnatural since the natural part of the country scene in this area was the horse and many affluent ratepayers kept their own horse.

Following many letters of objection from members of the Trail Riders Fellowship and the AJS/Matchless Club, the Council members, to their horror, discovered that their opponents were lucid, literate and even humorous, but otherwise quite determined to stop them closing the byways to vehicles. The committee duly adopted this recommendation. Hurrah!

(Nearly) Fully enclosed chain for ALL. This mod employs two Montesa Cota 348 chain tubes and can be adapted to fit any machine. The tubes cover top and bottom runs of the chain leaving only part of the sprockets exposed. Attachment to the swinging arm is achieved by a simple home-made mounting bracket. Total cost - £3. per tube (from your friendly Montesa dealer) and odd pence for the two brackets. SAE to me for comprehensive fitting instructions. Hurry while stocks last; a genuine not-to-be-missed offer.

Clutch and brake levers: It has been mentioned before (somewhere), but to avoid broken levers, slacken them slightly (not hanging below the bars, during) so in the event of a fall they move rather than snap.

Honda XL 125 gearbox sprocket: 4 Honda 90 gearbox sprocket fits straight on and is one tooth smaller than standar.

Chain others: Pete Plummer's T & M News column of 5th January described a chain other for 20p. I've had several letters commending this particular device and saying it actually works. Don't all look surprised. If you missed the article an SAE to me will ensure a copy.

Grab handles: For a cheap substitute for pukka grab handles, try rope lashed round indicator stalks or something similar.
